

## **COMMUNICATIONS** COMMITTEE **REPORT**

Once again it has been a very busy year! As the new chair of the Communications Committee. I can report that our goals remain the same. We are committed to the positive positioning of dentistry in the public consciousness, increasing dental office busyness, and promoting patients' long-term relationships with their Manitoba dentists. As we enter 2022, a new initiative that we are launching will help elevate the role of "Your Manitoba Dentist" and promote awareness that dentists are part of your overall healthcare team.

Budgeting lessons that we learned in 2020 were put into practice again in 2021. One by one COVID forced the cancellation of most of our events and sponsorships. In turn, this allowed us to dramatically increase our advertising and social media presence as we diverted funds to these initiatives. Despite our blueprint for the year changing, the 2021 marketing and communications initiatives that were implemented were done so within budget parameters. In fact, due in large part to bonusing by local media. Shaw Cable, and Winniped Transit the MDA was able to benefit from over \$113,000 in free media in 2021! Moreover, 80% of our television advertising is guaranteed to run in primetime during some of the most popular programs. To sum up, we got a ton of value for every dollar spent in 2021 and this has placed us in an enviable position as we continue to ride out the pandemic.

With COVID continuing to affect the business of dentistry in Manitoba and around the world, we

have continued our awareness marketing in order to support our members and to help them to maintain traffic within their offices. We opened the Spring of 2021 with the "We Miss Your Smile" campaign. The effect was two-fold in that it grew awareness for "Your Manitoba Dentist" while at the same time demonstrating the MDA's continued and strong support for mask mandates. The summer of 2021 began with strong optimism. With a rising vaccination rate in the province and with COVID numbers seemingly waning, public health authorities began to relax mask mandates. This was the motivation in preparing our fall campaign titled "It's time to Smile Again ... Your Manitoba Dentist". This campaign is one of celebration and features people without masks celebrating their smiles outdoors. Unfortunately, as production of this campaign was winding down, the increase in COVID infections and the subsequent emergence of the Omicron variant brought this plan to a screeching halt. As such, the decision was made to hold off on our campaign of celebration. Instead, the Fall campaign saw us continuing our "We Miss Your Smile" and "Wearing is Caring" campaigns on television and on bus tails. Nevertheless, the "It's time to Smile Again" campaign is completed and is ready to run in the Spring of 2022 or whenever we see the easing of public health restrictions.

Furthermore, similar to 2020, when online use exploded, our 2021 digital marketing return has expanded both from social media as well as from other online applications such as YouTube and Google. The 2021 campaign outperformed industry benchmarks by a significant margin. For example, with a 20.68% Click Through Rate

With regard to our social media presence on Instagram, Linked-in, Facebook, and Twitter, our number are continuing to grow. With that in mind, we are planning to boost these numbers further in 2022 with continued social media contesting and the use of influencers to gain reach, exposure, and followers. It is also worth mentioning that on digital we are going to begin streaming advertisements. Lastly, 2021 also saw the launch of the new MDA website complete with self-reporting CE. The Communications Committee was an integral part in getting this message out to our membership.

As we begin 2022, we are hoping for much fewer COVID-related cancellations, and we are optimistic that we will be able to achieve most of our marketing and communications initiatives. Regardless, we are ready to adjust our plan to benefit Manitoba dentists and the public as dictated by the pandemic situation. Most of our initiatives remain the same as in previous years with some new initiatives planned as well. Six 30 second public service announcements will be created to elevate the role of the dentist in everyday life and emphasize how important visiting "Your Manitoba Dentist" can be to your overall health. This will help to reinforce the image of the dentist as the primary expert in providing dental health care and advice.

In addition, in 2022 we will also be conducting public opinion research in the form of focus group testing. We last conducted this valuable research 3 years ago. In the past 3 years, we have seen our online presence dramatically increase. With these changes, and with the advancement of technology-based marketing and communication, it is essential to conduct this research in order to ensure that we are getting the best value for every dollar spent.

Once again Brian Fawkes and his team deserve congratulations in that two of our 2020 COVID response campaigns have garnered international recognition. Both "Here for You" and "Wearing is Caring" have each won a Summit International Award. The Summit organization dedicates itself to recognizing excellence in the communications and marketing industry and chose our campaigns from over 4500 entries from 20 different countries. This once again demonstrates how the MDA is at the forefront of high quality and effective marketing campaigns which places us well ahead of other PDA's. This also places us in an envious position when

## MDA TASK FORCE ON ACCESS TO DENTAL CARE IN NORTHERN AND REMOTE COMMUNITIES

2021 was a more active year for the Task Force as we emerged to a new normal during the COVID-19 pandemic. The MDA, through the Dental Association Act, regulates dentistry and dental assisting in Manitoba in the public interest. This would include members of the public located in Urban, Rural and Remote locations of the province.

The main board delegated goal for this Task Force continues to be to work to improve access to oral health care for Manitobans in northern and remote communities. We live in a geographically large province with a relatively small population – an intersection that can be a particular challenge for access to care. The committee is made up of a diverse group of generalists, specialists, and dental assistants with specific expertise related to delivering care in rural and remote Manitoba.

In 2021 the Task Force focused its efforts more specifically on developing a strategy to help address challenges to delivery of dental care unique to

First Nations communities. We recently began our consultative phase meeting with The Honourable Mary Jane McCallum, The Senate, Ottawa. Prior to her appointment, Senator McCallum spent most of the past forty-eight years providing dental services and treatment to First Nations in Manitoba as a dental nurse, dental therapist and dentist. From 1996-2000, she worked as the Regional Dental Officer for the province of Manitoba. This discussion helped us better understand some of the unique challenges facing delivery of care to First Nations peoples.

The coming year will see the group looking to shift and expand our consultation with indigenous groups in Manitoba. We are hoping that through listening and discussion, we can finalize a concrete set of priorities to help focus the MDA Board on their particular role in the goal of improved access to care.

Dr. Ken Shek will be taking over the Chair position as of our next meeting; we will continue on under his leadership until this by-law revision is complete. ## GENERAL PRACTICE STUDY CLUB REPORT

The General Practice Study club is open to all MDA members who are within their first five years of registration with the MDA and includes other senior members who attend sessions as facilitators. The format of the club consists of short lectures followed by Q & A sessions and small group discussions. The aim of each session is to supply continuing education and career support to practitioners early in their careers or who are new to practice in Manitoba.

Due to covid restrictions, lasting throughout the 2020/2021 academic year, the GPSC continues to provide ZOOM format lectures/"social" events for facilitators and participants. Several sessions closed with 'breakout rooms' which mimic in-person small group discussions. Back by popular demand, another mixology session was provided. In addition, charcuterie drop-offs, gift basket draws, and participant poll questions were utilized in attempt to replace the social aspect of the club. The remaining lecture for the 2021/2022 academic year is planned to be held in person this April, postponed from the previously scheduled March date.

As usual, lecture content has been spread out over several

specialty disciplines and has been tailored to subject areas of interest expressed by the target cohort, mainly communicated from our most junior members who polled their colleagues as well as direct messaging from the GPSC Instagram account.

Two vice chairs have been selected from the committee. One from rural Manitoba and one from Winnipeg, scheduled to enter into co-chair positions September 2022. Our hopes for the future of the GPSC is to return to the classic in-person sessions with emphasis on small group case discussion, but also to maintain some virtual content as rural participation is at an all-time high. In addition to regular session planning, a second retreat (to follow the only retreat which had intended to be annual, held in 2019) is on the horizon. In addition to the CE content provided at the retreat, some real-time, in-person connection is long overdue!

## SCOPE OF PRACTICE COMMITTEE REPORT

The Scope of Practice Committee was tasked with three matters to discuss, the Prosthodontic Module, Scaling Module and orthodontic assistant shortage.

The Prosthodontic Module had been in discussion for numerous years without any progress or conclusion. I am pleased to announce that the committee concluded their discussion and forwarded recommendations to the MDA Board to proceed with the establishment of a Prosthodontic Module for dental assistants.

Discussions on the scaling module concluded with an extension of the scaling depth to 3mm subgingival from the previous 2mm.

The Manitoba Orthodontic Society had concerns regarding the shortage of dental assistants with the Orthodontic Module

certification as a result of Red River College not providing the training due to the Pandemic restrictions. It was suggested that an alternative virtual training program be considered. The committee concluded that the assistant shortage is transitory and Red River College will be restarting their training program soon.

I would like to personally thank all of the committee members for their time, dedication and thoughtful discussions during the numerous virtual meetings held throughout the year.

## MDA PANDEMIC TASK FORCE

As the globe enters the third year of the COVID-19 pandemic, we watch as the Omicron wave begins to slow, hopefully giving rise to a period of reprieve for our hospitals and long-term care facilities and their hard working teams. The virus isn't likely to disappear; however, it appears that governments are looking to adapt to more sustainable management strategies for the future. With widespread vaccination and boosters, testing options and emerging treatments there is cause to be optimistic. The taskforce watches and waits to see signs of the SARS-CoV-2 virus response potentially entering some sort of an endemic phase although when viewed in a global context, there is still some road ahead.

## REGISTRATION AND LICENSING COMMITTEE

2021 has certainly seen it's fair share of challenges for our members. The registration and licensing committee is not exempt as our committee members are eager for in person meetings to facilitate the rewrite of this document.

In an extreme effort to work within the confines of our computer screens we feel that 2021 saw tremendous headway in review and redraft of the registration and licensing bylaw to ensure that this bylaw meets its foremost requirement. The health and safety of Manitobans.

Some of the most important discussions of the past year include, the acquisition of an ethics and jurisprudence certification for new registrants who graduated from schools outside Canada, as well as the necessity to development a cultural sensitivity course that will one day be required of all Manitoba dentists.

The committee has proposed that both criminal checks, and child abuse registry clearance for all members be in place prior to licensing, with renewals possibly coinciding with ones continuing education anniversaries. Third, it's been proposed that the raising

of malpractice minimum requirements and removing exclusivity to CDSPI as a malpractice provider is long overdue.

Furthermore, there has been special attention given to the Academic and Educator Classes as it pertains to license fees ,private practice work hours allowed , timelines at achieving NDSE and NEDB certification, and the college of dentistry's needs for future deployment of academics both specialists and general practitioners in externship situations. Finally, an in depth review of our specialists certification requirements as it pertains to the validity and necessity for both RCDC and NDEB specialist exams,how the public perceives specialists in Manitoba, as well as a review at the specialist's committee request for dual licenship. We are optimistic for a draft finalization by summer 2022.

## DENTAL IMPLANT SUB-COMMITTEE REVIEW

This committee continues to meet quarterly throughout the year to adjudicate claims submitted by prosthodontists and/ or surgeons. We review submissions for patients who fit into categories including Cleft Lip & Palate, Dental Dysplasias, Trauma, and Resection for Benign Disease. When these patients cannot be restored to adequate function using conventional prosthodontic techniques, our committee reviews individual patient records to decide whether the patient may qualify for implant-supported prostheses. If approved, the cost of the implant(s) is then covered by the Provincial Government.

Of note, Dr. Howard Cross, who is the current Director of the Cleft, Dysplasia and Craniofacial Program, will be leaving this government-funded position as of the end of February, 2022. At present, there has been no response from the Government of Manitoba regarding plans for another director moving forward. It remains unknown whether this committee will continue to function as it has been doing beyond the end of February, 2022.

## ECONOMICS COMMITTEE REPORT

The Manitoba Dental Association Economics
Committee serves several functions. Through 2021
the Committee generated a Suggested Fee Guide
for our members, engaged in surveys to acquire
data to aid in the fee guide production, continued to
participate in special 'Return to Practice' surveys to
assess the vitality of dental practice in Manitoba, and
the Committee continued to address questions from
MDA members, and insurance providers regarding the
appropriate interpretation and application of dental
procedure codes.

In order to help dentists properly interpret and apply procedure codes, an article entitled 'Conversation on Codes' will continue to appear periodically in the MDA Bulletin. This series of articles deals with some of the more common code interpretation/application queries that are directed to the MDA throughout the year by member dentists, insurance companies, and regulatory personnel alike. The aim of the article is to clarify common coding misinterpretations, and help direct dentists in the proper application of our procedure codes.

The production of the Manitoba Dental Association Suggested Fee Guides for 2022 involved the collection, comparison and tabulation of considerable data, and last year the Committee attempted to address some of the increased costs dentists were, and continue to be, faced with. Each year the MDA

Economics Committee works, in conjunction with Greg Finlayson, to analyze national and provincial economic data and engages in a very detailed interprovincial comparison of dental fees. The Committee also uses factors such as Manitoba's relative cost of living, projections for upcoming trends in disposable family income in Manitoba, unemployment rates, the consumer price index (CPI), projected private sector wage increases, changes in Gross Domestic Product (GDP), and expected changes in operating costs for dentists in Manitoba. As one might imagine, this data was (and continues to be) highly volatile.

Amongst the most important data the Economics Committee analyses is the survey data received from Manitoba dentists – particularly overhead cost data. These factors are used to create a Suggested Fee Guide that balances the affordability of dentistry for Manitobans against the continuing prosperity of our member dentists. In 2021, attempting to predict economic recovery from the pandemic for Manitoba (and Canada at large), continued to be extremely challenging.

The following table outlines some of the actual data points (compared to 2022 data projections) that were used to propose our fee increase for the upcoming year. This table compares actual data for 2019, 2020 and 2021 against those forecast for 2022.

The production of the Manitoba Dental Association Suggested Fee Guides for 2022 involved the collection. comparison and tabulation of considerable data, and last year the Committee attempted to address some of the increased costs dentists were, and continue to be. faced with.

From the above table, projections for most economic indicators for 2022 are quite positive for Manitoba's continued economic recovery. Unemployment rates are projected to continue to drop, housing starts are expected to be consistent with past years, GDP is strong, and employment growth is projected to be quite positive. Manitoba's population, as always, is projected to continue slow, steady growth. (These projections are subject to greater-than-usual volatility.)

Over the previous 3 years. Manitoba has ranked either number one or two in overall weighted fee increases as compared to the other provinces across Canada. For 2022, the overall across-the-board Suggested Fee Guide increase is 5.79% – an increase just slightly above the national average increase for 2022. In suggesting this fee increase, the MDA Economics Committee considered factors such as increased pandemic related operational costs (ongoing PPE requirements, extra operatory turn-around time, decreased patient flow, increased staff & wages costs), incoming new infection prevention control protocols (independent of COVID-19), the continuing affordability of dentistry for Manitobans, the ongoing sustainability of insurance plans, and other factors as well. It was a complex process, - especially so, since Manitoba is the first province to put forward it's fee

increase recommendation every autumn.

Drs. Fedorowich and Rohan continued to work with the administrative staff of the College of Dentistry and Dr. John Perry, Associate Dean Academics to outline a calendar for 2021-2022 with dates that do not conflict with exams and student commitments.

In lieu of the Graduation dinner held by the MDA, we sent our heartiest congratulations and best wishes to the Graduating Class of 2021 with MDA Mentorship Graduating Gift boxes which were given to each graduate. The gift boxes contained signed cards from MDA President, Dr. Chris Cottick, MDA co-chairs Drs. Rohan and Fedorowich. Fitted clinic jackets and scrub hats emblazoned with graduates' name and MDA logo and Cross Pen set.

The academic year 2021-2022 started with a Welcome to the Profession and introduction to the MDA Mentorship Program to the internationally trained dentists in the IDDP program. This session was conducted over Zoom to the 7 IDDP students.

The focus of the Mentorship program is to recruit dentists from all over Manitoba who are outstanding clinicians, committed to the profession and dedicated to encourage and support students for the 4 years of their schooling and as they transition into the profession. 



## **SPECIALISTS** COMMITTEE **REPORT**

In April 2020, the MDA was faced with having to make decisions on specialty licensure, as this was coming up at the national level. After many meetings and discussions, it was decided, voted on and passed, that specialists wanting to register in Manitoba could have either an NDSE certificate, or an RCDC certificate (designation). It is important to note that Manitoba is an outlier in this regard, as other provinces have chosen to bypass the RCDC and rely on the NDSE (NDEB) examination as a pathway to licensure. Politics prevailed in other jurisdictions, but Manitoba specialists believed that until the NDSE exam had some 'vears and data' under its belt, we would allow for both examinations towards specialty licensure to be acceptable. This is still in a state of flux in 2021-2022, as it is believed that the NDSE has, or is seriously considering, abstaining from running the specialist exams and turning it over to the RCDC.

There are three other issues of major concern for Manitoba specialists.

The issue of most importance has to do with the makeup of the Peer Review Committee. Based on our bylaws, a specialist brought before the peer review committee would not necessarily have a specialist of the same discipline, sitting on the committee adjudicating the complaint. In fact, the committee is not obligated to ask any specialist to sit on the committee for any particular complaint. The specialists of Manitoba believe this bylaw needs to

be changed which would address the importance of fairness and accountability. Presentations were made to the MDA and the Blue Ribbon committee of the MDA. Currently, the MDA is reviewing all of the material before it, with regards to this matter. The Blue Ribbon has met and we are awaiting their report.

The next two issues go hand in hand as they deal with scope of practice and the forfeiture of a specialist's general practice license once a specialist's license is granted. Defining a specialist's scope of practice is an extremely complex, multifactorial problem and ongoing discussions with the MDA are taking place.

When a dental specialist applies for a license in Manitoba to practice that specialty, that dentist must forfeit their general practice license. This regulation has been on the books for well over five decades, and Manitoba is an outlier in this regard as almost every province (exceptions are New Brunswick and Quebec) has informed us that a specialist who has the qualifications to practice as a GP (NDEB exam and licensure) may also obtain their GP license. This issue also involves Academic licensure as well. Discussions and meetings are ongoing and we await final reports from the MDA board regarding these issues. Respectfully submitted,
