The Dental Hygiene Transitional Council is in the process of developing regulations and standards for self-regulation and scope of practice. Discussions about self-initiation and independent practice have been muted by the recognition that the level of education and training of a dental hygienist does not support these activities. Patients should have a dental exam, diagnosis and treatment plan defined by a dentist and then duties delegated to appropriately-trained oral health team members.

**Umbrella Legislation and Future Task Force** Meetings have been held both with Government Representatives and separately with the Regulated Health Professions to develop the working principles for the development of overarching health disciplines legislation. At this time a consistent complaints and discipline system were being discussed, along with the list of reserved actions, in order to prepare for the draft of specific wording for the legislation that would be done in the summer of 2007.

**Anaesthesia By-law**

As of July 1, 2007 the College of Physicians and Surgeons will no longer audit dental offices where general anaesthetic services are offered. As a result, a new MDA By-law is required to detail the audit requirements and update other anaesthesia modalities in the By-law.

Although the Committee had defined the principles in a new By-law, which were reviewed by the Board, there were still a few administrative technicalities and definitions required in order to prevent any misinterpretation of the By-law.

**Canadian Dental Regulatory Authorities  
Federation**

On April 19, 2007 Dr. M. Lasko and Dr. M. Van Woensel attended a meeting of Canadian Dental

Regulatory Authorities Federation which was held in Ottawa.

The main point of discussion was of a document describing the assessment, gap education, and examination of dental specialists who did not have an NDEB Certificate, or graduate from an accredited specialty program. Currently there was considerable debate among the provinces about the wording in the document as it appeared that a format war was taking place. Although a specific document was not available for the Board to consider the principles considered in February were still in place as well as the requirement for a dentist trust fund to be held and available for the costs of the NDEB for specialist exam development.

**Dental Anaesthesia**

The Board learned that the request for specialty status of Dental Anaesthesia had been reviewed by the Council on Education. The COE accepted that the criteria had been met and that the request could go to the CDA Board of Directors for consideration.

As a result, the MDA Board supported a recommendation that the MDA write to the CDA Board of Directors expressing its concern about consideration of Dental Anaesthesia for specialty status and ask for a specific response to the MDA's questions about the criteria necessary for the application to be considered.

**Faculty Update**

Dr. Randy Mazurat, Acting Dean, updated the Board on the following items:

- The new Dean will begin July 1, 2007. His first emphasis will be on the organization of the 50<sup>th</sup> Anniversary celebrations for the Faculty and increased emphasis on the research activities at the Faculty;
- Accreditation documents are being prepared for a site visit being scheduled for late January or early February, 2008;
- The Dental Hygiene class expansion request will be going to the University's Board of Governors in early June, 2007 the decision should be known soon with an implementation date of September, 2008;

# President's Message

*"The more things change the more they stay the same."* Alphonse Karr

The more I think about life, the more I realize it's about relationships. Good relationships generate trust and understanding. Even in disagreement there is respect for another's opinion. Problems are resolved by willingness to compromise or acceptance of differences. In bad relationships, even when people are in fundamental agreement there is distrust and questions of another's motivation. Often both parties look for an excuse to fail and an opportunity to blame. Actions are viewed negatively, and intentions always are suspect.

This is obvious in dental practice. If a patient's treatment does not give the desired result, a good relationship will not only engender their understanding, but also motivates me to find alternatives to help them. In cases with a bad relationship, the patient will find a reason to be unhappy even if treatment is successful. Like most dentists, I spend a significant amount of time working to develop a positive relationship with all my patients to avoid the latter. If a new patient enters the practice with a negative attitude about dentistry, I take the time to determine what the real issues are - fear, cost, distrust. I look for solutions explaining bluntly but sincerely I am here to help and if they do not truly believe that, they will unlikely be satisfied with their care.

Similarly, oral health team members will work to ensure your success in a good relationship. They will accept your bad days, understanding you are only human. In a bad relationship, a member will often work to undermine other relationships with staff or worse patients making the office dysfunctional.

A number of legislative changes are in the process or have occurred in dentistry. Licensure of dental assistants, self regulation of dental hygienists and omnibus health professions legislation potentially altering the structure of the MDA. These are significant changes but their real impact will be dependent on relationships. Things will fundamentally stay the same if our relationships with patients and OHT members

are good. I am uncertain whether our patients are loyal or reluctant to change, but they rarely leave an office when they have a positive, trusting relationship with the dentist. The same is true with OHT members. However, if a patient's only relationship in an office is with the hygienist, there is potential their loyalty is to the hygienist.

The legislative changes for dental assisting and dental hygiene will not change the current relationship between them and a dentist in private practice. Dentists are expected to be leaders of the oral health team and are responsible for patient safety in their offices. As dentists, we should encourage our staff to participate and develop a positive relationship with their professional bodies. The input of individual members will ensure an effective organization that meets the true needs of the public and themselves.

The same can be said about the relationship between the dental profession and the community. As a profession, we are well respected for our high standards of care. I believe our communities trust we - as individuals and as a profession - are striving to meet the province's oral health needs. It is important we value and foster this relationship. With the high demand for our services, there are people in our communities who have difficulty accessing oral health care.

As a profession we should support programmes and new solutions to help our under serviced populations - seniors, the institutionalized, indigent, geographically remote and the working poor. The Faculty of Dentistry's Children's Outreach programme is an excellent example. It provides care for many children from the most economically disadvantaged areas of Winnipeg. The Variety Club has developed a Tooth Fairy Bracelet campaign to raise money for the Outreach programme (you will receive a letter from the Variety Club and the MDA encouraging participation).

Through generous donations from Saul Sair and others, Siloam Mission is in the process of opening a multidisciplinary health care clinic. The facility will contain a staffed state of the art dental clinic providing dental services to people who may not have access to care. It is their hope and mine, dentists in the province will be willing to support the clinic by volunteering time on a one time, weekly, monthly or annual basis. ### **Welcome New Registrants!**

Summer is always a time for renewal. The MDA Office has been very busy with the completion of the university term and the processing of the graduates from our Faculty of Dentistry. From a class of 35 dentists we are in the midst of registering and licensing approximately 15 new dentists who have chosen to stay in Manitoba.

Congratulations and welcome to the profession!

### **Canadian Dental Regulatory Authorities Federation (CDRAF)**

Dental Licensing Authorities are progressing, albeit rather slowly, with the process to recognize Internationally Trained Dental Specialists. A special Summit meeting dedicated to this issue was held in Toronto February 16-18, 2007 attended by Dr. Marcel Van Woensel and myself. The extensive deliberations at that meeting resulted in all of the licensing authorities accepting a process to evaluate and provide gap education and examine the successful individuals to enable them to be eligible for licensure.

A Memorandum of Understanding (MOU) is currently being reviewed and revised to enable this process to be in place sometime in 2008. Significant work remains to be done to involve the multitude of stakeholders that must be consulted to allow this to come to fruition.

The CDRAF met on April 19, 2007 in Ottawa with a full agenda of issues regarding licensing concerns across Canada and was attended by the MDA President and myself. Part of that agenda was a continuation of discussions regarding the MOU for Specialty Recognition.

### **Dental Assisting**

The registration process has been completed for those dental assistants who work intra orally and currently we have 875 who have renewed their certificates to be actively employed in dental offices.

The MDA is continuing to consult with those Registered Dental Assistants and complete further By-Law development which will include the development of: a Peer Review Committee; requirements for professional liability insurance; a Registration Committee; the election of a Dental Assistant to the MDA Board; and a Continuing Education Committee. As this process develops, it would be helpful if our member dentists could encourage interested dental assistants that they employ to contact the MDA to volunteer to serve on these Committees.

The MDA Dental Assistant Board Member, Ms. Maryanne Clark, and myself, attended a meeting of the Dental Assistant Regulatory Authorities in Ottawa on April 18, 2007. The agenda included discussions about dental assistant regulation, labour mobility updates, NDAEB, and CDAC reports.

### **Dental Hygiene Transitional Council**

The council continues to meet on a regular basis to develop the process to establish the College of Dental Hygienists of Manitoba. Dr B. Schroth and I participate and can be consulted if any inquiries exist about the process.

### **Umbrella Legislation**

The MDA, together with 20 other self-regulated professions, continue to meet to attempt to develop overarching legislation to replace existing Statutes. The main areas of discussion have been the Complaints Process, and Scope of Practice. Mr. Ross McIntyre is the MDA representative taking part in those discussions.

### **Anaesthesia By-Laws**

As most of you are aware, the MDA will be solely responsible for office audits of those dental offices where sedation and anaesthesia is provided. A complete review of our existing By-Law and office audit protocol is underway and should be completed in the summer. The revised document will be considered by the Board of Directors of the MDA at its June 7<sup>th</sup> meeting and sent out for your approval once approved by the Board.

### **Peer Review Committee**

The Peer Review Committee met on May 17, 2007 for an orientation presentation for committee members. Three new members were approved for 3-year terms, Dr.'s W. Bohn, G. Ferens and K. Wiebe.

- An Associate Dean-Administration is being sought;
- The survey of Alumni will be published in the Faculty's Bulletin and there is assurance that the Faculty will act on the recommendations;

### Communications Committee

Dr. J. Antel, Communication's Committee Chairman, updated the Board on the following items:

- The Task Force on Developing Better Relations Between the MDA and Faculty has prepared its report and recommendations;
- Specialists have been consulted about the MDA TV ads and accepted the tag line changes, and that a specific ad will be developed for 2008;
- The web-site is being revamped to contain all of the MDA promotional material;
- The newsprint ads by denturists seem to be using similar wording to MDA ads. However, denturist's capabilities of doing implant design, diagnosis and planning are at best questionable. The Registrar will investigate this matter.

### USC & LS (Fee Codes)

Mr. R. Mohammed attended a meeting from March 31 – April 1, 2007 where the Uniform System of Codes and List of Services was discussed. The principles discussed were: that it should be inexpensive to use; avoid miscoding; searchable; usable for research; and adaptable for future needs. Foremost was the request that a 5 digit code be maintained with no expansion to a 17-digit code.

### CDSPI

Information presented indicated that the insurance and investment plans of CDSPI were being subscribed to by more dentists and, in turn, becoming more successful.

Discussions about a repeater formula for dentists with multiple malpractice claims ended with a decision that no formula would be utilized and that all participants would pay the same fees and deductibles in the group plan. Claims will be monitored to determine if this topic needs to be revisited.

## IN MEMORIAM

### W. IVAN JACKSON, D.D.S.

Dr. W. Ivan Jackson passed away on May 9, 2007 in the Royal Jubilee Hospital in Victoria, B.C. at the age of 92. Born in Winnipeg in 1915 he attended Kelvin High School and graduated from the University of Minnesota three-year dental program in 1937 and received his Doctor of Dental Surgery degree from the University of Alberta in 1938. Returning to Winnipeg he joined his father, Dr. Phillip A. Jackson, in practice. During World War II Ivan served with the Royal Canadian Dental Corps from 1941 to 1944 in both Canada and the United Kingdom.

Following military service Dr. Jackson resumed his Winnipeg practice in the Somerset Building and later in the Medical Arts. A member of the American Academy of Restorative Dentistry for many years he was instrumental in founding the Tuxedo Park Dental Group in 1967 where he limited his practice to the art and science of restorative dentistry until retirement to Victoria, British Columbia in 1979. Ivan was president of the Winnipeg Dental Society in 1948-49 and the Manitoba Dental Association in 1961-62. An avid sportsman he excelled in downhill skiing and Nordic ski jumping.



## The Dental Specialist

"The Dental Specialist" is written by Manitoba Dental Specialists. Each issue features one of the dental specialty groups (on a rotational basis). In this month's issue, the article is submitted on behalf of the Periodontists.

### Lasers in periodontics

There has been a surge in the interest of lasers in dentistry, with many claims of reduced pain for the patient, cleaner work environment, time efficient procedures and reduced healing time. Different lasers have been successfully used in dentistry for soft tissue procedures and caries removal. However, controversy exists regarding the use of lasers in the treatment of chronic periodontitis despite numerous claims of their effectiveness.

Lasers have been used in medicine since the 1960's when Maiman developed the first prototype using a ruby crystal that emitted a coherent light when stimulated.<sup>1</sup> Ruby lasers were eventually replaced by CO<sub>2</sub>, Nd:YAG (Neodymium, Aluminum, Yttrium, Garnet), Er:YAG (Erbium, YAG), Er,Cr:YSGG. The most commonly used lasers for soft tissue in dentistry today are the CO<sub>2</sub> and Nd:YAG lasers.<sup>2-3</sup> The Er:YAG is used most often used for removal of caries. The suitability for application to tissues is determined by the wavelength of a laser. The range of wavelengths in lasers used in medicine and dentistry range from 194nm (nanometers) to 10,600 nm. Different lasers exist with qualities that make them suitable for certain procedures, will be described.

#### CO<sub>2</sub> Laser

The wavelength of the CO<sub>2</sub> laser (10,600nm) is readily absorbed by water<sup>4</sup>. Soft tissue is 75-90% water and thus most of the energy of the laser is absorbed at the tissue surface with little scatter or penetration. Cutting is accomplished by vaporizing tissue along a line close to the focal point. Divergence of the beam beyond the focal point results in a rapid loss of power density and protects the underlying tissue. Protein denaturation and coagulation occur in the immediate area under the incision.<sup>5</sup> An advantage of CO<sub>2</sub> laser over conventional surgery is hemostasis and increased visualization of the operating field.

*The CO<sub>2</sub> laser is useful for soft tissue procedures including gingivectomy, and excision of soft tissue pathology. Avoid contact with hard tissues to prevent heat damage 4*

#### Neodymium:YAG laser

The energy of the Nd:YAG laser (1064nm) scatters in soft tissue rather than being absorbed as in the CO<sub>2</sub> laser. The energy penetrates to a depth of 60mm before it is attenuated 10%, thus heating considerable more tissue. Thermal damage may occur to the underlying bone<sup>6</sup>, and in vitro studies have reported intrapulpal thermal damage when the laser was used to remove the smear layer from roots.<sup>7</sup>

*The Nd:YAG laser is recommended for removal of soft tissue,*

*including hemorrhagic soft tissue lesions. Avoid contact with hard tissues. Penetration of energy may go 2-4mm below surface causing underlying hard tissue damage 4.*

#### Erbium: YAG laser

The wavelength (2940nm) of the Er:YAG is highly absorbed by water and hydroxyapatite causing much less thermal damage than the Nd:YAG into underlying tissues and minimal elevation of the pulpal temperature. Studies have demonstrated its ability to remove lipopolysaccharides from root surfaces, remove the smear layer after root planing, and remove calculus and cementum.<sup>8-9</sup> Despite the ability of the Er:YAG laser to remove these deposits, mechanical debridement of subgingival calculus has been demonstrated to be clinically more effective at removal of deposits than the laser and less time consuming.<sup>10</sup>

*The Er:YAG laser is recommended for cavity preparation of incipient caries 4.*

#### Diode laser

The energy of the diode laser is delivered at a wavelength of 819nm and is absorbed by pigmentation of soft tissues, making it suitable for hemostasis. It is used for soft tissue removal in a contact mode that is similar to electrocautery.

*The diode laser is suitable for removal of soft tissues, especially hemorrhagic lesions. Avoid contact with hard tissues to prevent thermal damage. Penetration of energy is less than with the Nd:YAG laser 4.*

#### Lasers in the treatment of chronic periodontitis

The primary goals in the treatment of periodontitis are the removal of bacterial contaminants and the cessation of progression of disease activity. There is considerable evidence to support scaling and root planing in the treatment of periodontitis. However, practitioners are interested in treatment that will achieve the same goals more efficiently and with less instrumentation. The literature regarding the use of lasers in the treatment of chronic periodontitis, however, remains controversial. Current evidence suggests that lasers are equivalent to conventional scaling and root planing with respect to reduction in probing depths, bleeding on probing and subgingival bacterial populations.<sup>11</sup> Eberhard et al<sup>12</sup> reported that for the same length of time, manual debridement was more effective than the laser (Er:YAG) in removal of subgingival calculus. Further, given twice the time, the laser did not reach equivalent results of hand instrumentation. Despite numerous studies, it is nearly impossible to compare results because differences in tissue and irradiation of tissue (laser parameters) have not been accounted for and standardized between studies. Wavelength, time, distance from tissue, tissue factors, and severity of disease are important parameters in experimental design for lasers that need to be controlled. Insufficient reporting on parameters of lasers renders comparisons near impossible, not only between laser and conventional therapy, but also between lasers, of similar and different wavelengths.

Current evidence does not suggest that the use of lasers provides any additional benefit in the treatment of chronic periodontitis compared with conventional modes of

periodontal therapy. Until higher levels of evidence prove otherwise, investments in lasers should be considered with prudence.


